- 5. Records of Process parameters and product checking results are to be retained for a period of 2 years & Metallurgical micro samples are to be preserved for a period of 6 month.
- 6. You need to continuously comply with the process parameters mentioned in the approved IPO sheet, In case any deviation found in process control or product quality, BAL may impose penalty as per guidelines & your HT approval may get cancelled.
