

COD :1200

BOD :600

TDS :2100

TSS :500

PH :6 to 8

If your outlet parameters are not confirming to these parameters, after primary treatment, please discuss the matter immediately. If we do not hear from you within a week, it will be binding on you to adhere to these limits.

The Small Scale Industry members are requested to submit their effluent analysis immediately so that any objectionable element can be recovered and outlet parameters can be finalized for designing the CETP.
