<u>Sub</u>: Implementation of the E.S.I Act, 1948 & Registration of Employees of the Factories and Establishments under Sec <u>2[12]</u>/1[5] of the Act as amended -Issue of Registration Certificate - reg <u>Ref:</u> Form <u>C - 10</u>/Form-01 dated 30.03.2011.

- It is informed that under Section 1[3] of the E.S.I Act, 1948 the Central Government has vide Notification No. <u>S.O.319</u> dated <u>10.01.1972</u> made the provisions of the Act applicable to all Factories/ Establishments covered under the Act within the [Area] <u>DHARWAD</u>.
- 2. It is further informed to you that the appropriate Government has extended the provision of the Act to other Establishment under Section 1[5] of the Act vide Notification No. <u>SWL.124.LSI.74A(III)</u> dated <u>18.02.1976.</u>
- 3. Under Section 2.A of the Act such a Factory/Establishment is required to register itself under the Act and chapter IV thereof casts a responsibility on the principal employer thereof to insure his employees and pay contributions in respect of these employees covered under the Act.
- 4. On the basis of the particulars in respect of your Factory/Establishment submitted by you/the report of the inspection conducted by the Insurance Inspector/Branch Office Manager who inspected your Factory/Establishment <u>vide Form-01/C-10-dated: 30.03.2011</u>, falls within the purview of the Section 2[12]/1[5] of the Act, DATE OF COVERAGE is with effect from <u>01.03.2011</u>. In case however, subsequent facts reveal that your Factory/Establishment was coverable from a date prior to the date mentioned above, you shall make yourself liable to comply with the provision of the Act from such earlier date.
- 5. You are requested to take immediate steps for registration of your employees by submitting Declaration Forms, payment of contribution, maintenance of record etc., from the date of coverage of your Factory/Establishment under the Act.

- 6. For the sake of convenience, your establishment has been allotted Code No. <u>58.00.005111.000.1001</u> which may kindly be used in all communication sent to this Office and on all form at the places indicated for the purpose. The Branch Office of the Corporation situated at <u>Near Hubli Toll Naka, Saraswathipuram, Dharwad-580 002</u> has been instructed to render necessary assistance to you in connection with registration of your employees. In case you find any difficulty or for any other purpose which may be necessary in connection with the Scheme, you are requested to contact the Manager of the above Branch Office who will render necessary help in the matter.
- 7. It is requested that publicity may kindly be given to list of Insurance Medical Practitioners, State Insurance Dispensaries to enable your employees to choose their State Insurance Dispensaries/Insurance Medical Practitioner. Required forms etc., may please be collected from the Branch Office mentioned above to which all your employees will also be attached.
- 8. The Corporation Officials would be pleased to give all necessary and possible guidance to you in discharging your duties and obligations under the ESI Act, 1948, and I am confident of prompt and early compliance under the provisions of the ESI Act and Regulation on your part.
- 9. You are requested to remit contribution through on-line challan generation at SBI, DHARWAD.
