The E.S.I. Corporation has embarked upon IT Roll-Out, as the nature of tasks being performed by the E.S.I.C have become increasingly complex. The E.S.I.C has expanded its reach and consequently the complexity of its operations has increased manifold. In the coming years, the functions that will be performed by the E.S.I. Corporation would become more and more diverse and expectation of our Insured Persons are bound to increase. In the circumstances, it becomes imperative to introduce IT solution to improve delivery standards. E.S.I. Corporation has, therefore, undertaken the 'Project Panchdeep' to plan and execute this "e-governance" project.

2. Accordingly, at the initial phase, action is taken to establish error-free identification of the beneficiaries. Declaration Forms have to be obtained afresh from all the employees. They will be supplied with two **smart cards** (one for the insured person and the other for his family) containing **bio-metric data** viz., the personal data, photographs and finger-prints of all the beneficiaries. These cards can be used throughout the country. In order to collect the bio-metric details, including the fingerprints of the employees and the members of their families, all the employees must attend specified Enrolment Camps for photo sessions with all their family members. Details regarding date, venue etc. of the camps may be ascertained from our Branch Office to which you are attached.



I, therefore, request you to kindly extend your co-operation as envisaged under Regulation 16 of the ESI ( General) Regulations, 1950, by obtaining and forwarding the details of your employees in the fresh Declaration Forms enclosed and by enabling them to attend the Enrolment Camps for photo sessions with **all** their family members. The Declaration Forms can also be downloaded from the web [http://www.esichennai.org/forms/DF\\_form1.pdf](http://www.esichennai.org/forms/DF_form1.pdf). The Insurance Numbers already allotted to the Insured Persons will continue to be used without any change.
