It is noticed that your establishment (i) is engaged in an industry viz. COMMERCIAL as specified in Schedule-1 of the Employees' Provident Funds and Miscellaneous Provision Act. 1952/a class of establishments to which the Provisions of the above-said Act has been made applicable. (ii) has completed 3 years on or before 22-7-97 from the date of set-up, and (iii) has employed more than 19 persons on JULY-2000. Accordingly, the Employees' Provident Funds and Miscellaneous Provisions Act. 1952. is applicable to your establishment alongwith head office/branches/departments U/s. 1 (3) (a), 1 (3) (b) provisionally/ finally with effect from JULY-2000 for which Code No. GJ/BD/21973 is allotted to you. This Code Number should invariably be referred to in all correspondence with this office. The final date of coverage could be shifted back after checking the relevant records.

2 As provided in Para 26 of the Employees' Provident Funds Scheme, 1952, all employees, whether full time or part time, employed in or in connection with the work of the establishment including employees employed by or through a contractor shall be eligible from membership of the Fund from the first of the following month. Relevant extracts of Para 26 of the Scheme are reproduced below :-

(i) Every employee who on the date viz. JULY-2000 (mentioned above) has completed three months' continuous service or has actually worked of not less than 60 days during a period of three months or less in your factory/establishment or in any other factory or establishment to which the Act. applies under the same employer or partly in one and partly in the other, or has been declared permanent in any such factory/establishment whichever is the earliest, shall be entitled and required to become a member of the Fund from the beginning of following month.


