(1) The licence shall be non-transferable.

- (2) The number of workmen employed as Contract Labour in the establishment Cosmo Films Ltd, Plant: Vemardi Road Village Navi Jithardi, Near Inox, N.h No. 8, Taluka Karjan, establishment shall not, on any day, exceed **150**.
- (3) Except as provided in the rules the fees paid for the grant, or as the case may be, for renewal of the license shall be nonrefundable.
- (4) The rates of wages payable to the workmen by the contractor shall not be less than the rates prescribed for the scheduled of employment under the Minimum Wages Act, 1948, where applicable , and where the rates have been fixed by agreement, settlement or award, not less than the rates so Fixed.

- (7) every establishment where 20 or more women are ordinarily employed as contract labour, there shall be provided 2 rooms of reasonable dimensions for the use of their children under the age of six years. - (9) Contractor shall employ 85% of the skilled, semiskilled and unskilled contract workmen from the local resident, who are living in Gujarat since last 15 years, and will maintain the 85% strength till the completion of the valid License. If the local residents are not available then the contractor shall employ the remaining more than 15% of the non-local contract workmen after obtaining the prior written permission of the respective Licensing officer appointed under the Act.
