Dear Sirs,

I have to inform you that under Section 1(3) of the E.S.I. Act the Central Govt. has vide Notification No. 13(45)65 HT dated 4-8-65 <sup>ref 15-8-65</sup> made the provisions of the Act applicable to all factories/establishments covered under the Act within the area.

I have further to inform you that the appropriate Govt. has extended the provisions of the Act to other establishment under Section 1(5) of the Act with effect from 27-11-76 vide notification No. ESI-1875/800 dated 19-11-76.

Under Section 2-A of the Act, such a factory/establishment is required to register itself under the Act and Chapter IV thereof casts a responsibility on the employer thereof to ensure its employees and to pay contributions in respect of such employees covered under the Act.

On the basis of the particulars in respect of your factory/establishment submitted by you, the ~~report of the inspection conducted by the Insurance Inspector of your factory/establishment on 3-10-88~~ <sup>ref 11-11-88</sup>, your factory/establishment falls within the purview of Section ~~2(42)~~ 1(5) of the Act with effect from 1-7-88 (prov.). In case, however, subsequent facts reveal that your factory/establishment was coverable from the date prior to the date mentioned above, you shall make yourself liable to comply with the provisions of the Act from such earlier date.

You are requested to take immediate steps for registration of your employees by filling in declaration forms, payment of contributions, maintenance of records etc. from the date of coverage of your factory/establishment under the provisions of the Act.


For the sake of convenience, your establishment/factory has been allotted Code No. 33-32280-64 which may be used in all communications sent to this office and all forms at the spaces indicated for the purpose. The Local Office of the Corporation is situated at Hadpsar has been instructed to render necessary assistance to you in connection with the registration of your employees.
