Required forms etc. may please be collected from the Branch Office mentioned above to which all your employees will also be attached.

- 8. The Corporation Officials would be pleased to give all necessary and possible guidance to you in discharging your duties and obligations under the ESI Act, 1948, and I am confident of prompt and early compliance under the provisions of the ESI Act and Regulation on your part
- It is informed that the Central Government (Vide Notification No. S-38025/04/2010-SS.I dated 20/04/2010) has issued the final Notification enhancing Wage Ceiling for coverage under ESI Act from Rs. 10000/- to Rs. 15000/- per month, w.e.f. 1st May 2010. Accordingly, under ESI Act from Rs. 10000/- to Rs. 15000/- per month, we.f. 1st May 2010. Rs. 15000/- per month, would become coverable under the E.S.I. Act, w.e.f. 1st May 2010.
- 10. You may choose one of the Branches of State Bank of India which is convenient to you, under intimation to this office and to this office and to the concerned branch of the State Bank of India and deposit the ESI dues in that Branch only. In case no intimation is received within 15 days of the receipt of this letter the amount of contribution deposited in one of the specified branch would be considered as "Nominated Branch" for your establishment.
