- (2) The number of workmen employed as Contract Labour in the establishment TOTO INDIA INDUSTRIES PVT LTD, GIDC PHASEII, HALOL INDUSTRIAL AREA, CHANDRAPURA, HALOL ,PANCHMAHAL -389350, GUJARAT,
- (3) Except as provided in the rules the fees paid for the grant, or as the case may be, for
- (4) The rates of wages payable to the workmen by the contractor shall not be less than the rates prescribed for the scheduled of employment under the Minimum Wages Act, 1948, where applicable , and where the rates have been fixed by agreement, settlement or
