Employees of the Factories and Establishments under
See 2(12)/1(5) of the Act as amended.

1. I Have to inform that under Section 1 (3) of the E.S.I. Act, 1948 the Central Government has vide notification No ~~U-38011/14/86/251~~ dated ~~14.4.88~~ made the provisions of the Act applicable to all factories/Establishments covered under the Act within the (Area) ~~Hebbagodi, Binny Fields~~.
2. I have further to inform you that the appropriate Government has extended the provision of the Act to other establishment under Section 1 (5) of the Act with effect from (vide notification No dated)
3. Under Section 2-A of the Act such a factory/Establishment is required to register itself under the Act and chapter IV thereof casts a responsibility on the principal employer thereof to insure its employees and to pay contributions in respect of these employees covered under the Act.
4. On the basis of the particulars in respect of your factory/Establishment submitted by you/ the report of the inspection conducted by the Insurance Inspector/Local office Manager who inspected your factory/Establishment on ~~23.3.88~~ your factory/Establishment falls within the purview of Section 2 (12)/1 (5) of the Act with effect from ~~27.7.93~~ provisionally. In case, however, subsequent facts reveal that your factory/Establishment was coverable from a date prior to the date mentioned above you shall make yourself liable to comply with the provision of the Act from such earlier date.
5. You are requested to take immediate steps for registration of your employees by submitting Declaration forms, preparation of contribution cards and payment of contribution maintenance of record etc., from the date of coverage of your factory/Establishment under the Act.
6. For the sake of convenience your establishment has been allotted code No **53-13084-90** which may kindly be used in all communications sent to this office and on all forms at the places indicated for the purpose. The Local office of the Corporation situated at **No. 159/1** ~~1st Floor, 15th Cross, Hoosur Road, Bangalore-56~~ has been instructed to render necessary assistance to you in connection with registration of your employees. In case you find any difficulty or for any other purpose which may be necessary in connection with the Scheme, you are requested to contact the Manager of the above Local office who will render necessary help in the matter.
