

**RENEWAL AGREEMENT**  
**To Service Agreement dated 21<sup>st</sup> April 2023**

This Renewal Agreement ('Agreement') To Service Agreement dated 21<sup>st</sup> April 2023 is entered into on this 30 day of March 2024 ("Execution Date") between:

**CORONA Remedies Private Limited**, a company incorporated under the provisions of the Companies act 1956, having its Registered Office at "Corona House", "Block C", Mondeal Business Park, Nr. Gurudwara, S.G. Highway, Thaltej, Ahmedabad-380059. Gujarat. India. (Hereinafter referred to as "Customer" which expression shall mean and include its successors, assigns and subsidiary/associates companies) as the first party:

AND

**PCI Pest Control Private Limited**, a company incorporated under the provisions of the Companies act 1956, having its Registered Office at Villa No.3, Crescent Villa, Candolim, Goa - 403515 and Corporate Office at Narayani Bldg, Aarey Road, Goregaon West, Mumbai 400104 (hereinafter referred to as "Service Provider" which expression shall mean and include its successors, assigns and subsidiary/associate companies) as the second party;

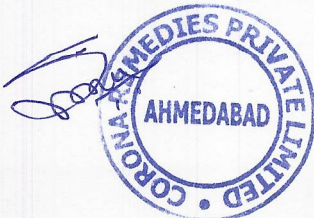
Customer and Service Provider shall hereinafter referred to individually as 'Party' or collectively as 'Parties'.

WHEREAS,

- a) The Parties entered into a Service Agreement dated 21/04/2023 which is valid upto 31/03/2024 ("Original Agreement").
- b) Through this Agreement, the Parties have mutually agreed to extend the term of the Original Agreement for a period of 1 (One) year with effect from 01/04/2024 to 31/03/2025.
- c) Accordingly, the Parties are entering into this Agreement with a view to record the agreement and arrangement reached between them.

**NOW THIS RENEWAL AGREEMENT WITNESSETH AND IT HEREBY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:**

1. The terms and references which are not defined herein shall have the meanings ascribed to them in the Original Agreement.
2. In terms of clause No.2 of the Original Agreement, the Parties have mutually agreed to extend the Term of the Original Agreement for a period of 01 (One) Year with effect from 01<sup>st</sup> April 2024 to 31<sup>st</sup> March 2025.
3. In terms of Annexure I (Services/Scope of Services) and Annexure II (Commercials) of the Clause "SERVICES" of the Original Agreement, the same shall be replaced with Annexure I and Annexure II of this Agreement.



4. All other provisions of the Original Agreement not expressly amended by this Renewal Agreement shall remain unaltered.
5. The terms of this Renewal Agreement are hereby incorporated by way of reference into the Original Agreement and the Original Agreement incorporating the terms of this Renewal Agreement shall be construed as one and single Agreement.
6. This Renewal Agreement may be signed in two counterparts, each of which shall be deemed an original and both of which, taken together, shall constitute one and the same instrument. This Amendment Agreement may also be signed in separate originals, through digital signature, facsimile, physically signed and scanned copy exchanged over email, or \*.pdf electronic counterparts, each of which shall be deemed an original, and all of which shall be deemed one and the same instrument.
