- v) All the test certificates issued by the Competent Person shall contain the latest No. and date of the Certificate of competency issued to a person (or) Institute by this office, along with the validity period of the competency.

The Competent Person shall make an application with all relevant documents for issuance of fresh certificate, if needed, 30 days before the expiry of this certificate.
