Subject: Implementation of the E.S.I. Act, 1948 and Registration of Employees of the Factories and Establishments under Section 2(12)/4(5) of the Act as amended.

Dear Sir/s,

1. It is informed that under Section 1(3) of the E.S.I. Act, 1948 the Central Government has vide notification No S.O.4202 dated 24-11-68 made the provisions of the Act applicable to all factories/establishments covered under the Act within the (Area) Bangalore.
2. It is further informed that the appropriate Government has extended the provisions of the Act to other establishment under Section 1(5) of the Act with effect from (vide notification.....dated)
3. Under Section 2-A of the Act such a factory/establishments is required to register itself under the Act and chapter IV thereof casts a responsibility on the principal employer thereof to insure his employees and pay contributions in respect of these employees covered under the Act.
4. On the basis of the particulars in respect of your factory/establishment submitted by you, ~~the report of the inspection conducted by the Insurance Inspector/Branch Office Manager who inspected your factory/establishment on 06-04-11~~ your factory/establishment falls within the purview of Section 2(12)/4(5) of the Act with effect from 01-06-10. In case, however, subsequent facts reveal that your factory/establishment was coverable from a date prior to the date mentioned above, you shall make yourself liable to comply with the provision of the Act from such earlier date.
5. It is requested to take immediate steps for registration of your employees by submitting Declaration forms, payment of contribution, maintenance of record etc., from the date of coverage of your factory/establishment under the Act.

6. For the sake of convenience your establishment has been allotted code No 4900-030856-0000599 which may kindly be used in all communications sent to this office and on all forms at the place indicated for the purpose. The Branch Office of the Corporation situated at Peenya I has been instructed to render necessary assistance to you in connection with registration of your employees. In case you find any difficulty or for any other purpose which may be necessary in connection with the Scheme you are requested to contact the Manager of the above Branch Office who will render necessary help in the matter.

It is requested that publicity may kindly be given to list of Insurance medical practitioners, State Insurance Dispensaries to enable your employees to choose their State Insurance Dispensaries/Insurance Medical Practitioner. Required forms etc., may please be collected from the Branch Office mentioned above to which all your employees will also be attached.


