I have to inform that under section 1(3) of the ESI Act, 1948 the Central Government has vide notification No. SS-121(118) SRO 3484 dated 09/11/1955 made the provisions of the Act applicable to all factories covered under the Act within the area.

- 2. I have further to inform you that the appropriate Government has extended the provisions of the Act to other establishments under section 1(5) of the Act.
- 3. Under section 2A of the Act, such a factory/establishment is required to register itself under the Act and Chapter IV thereof easts a responsibility on the principal employer thereof to insure its employees and to pay contributions in respect of such employees covered under the Act.
- 4. On the basis of the particulars in respect of your factory/establishment submitted by you/ the report of the Inspection conducted by the Inspector/Branch Manager on 01/07/2005 your factory establishment falls within the purview of Section 2(12) of the Act with effect from 25/07/2005 (Provisionally/Finally).
