- i. To assist in submitting reimbursement claims towards stipend paid to apprentices.
- j. To assist the establishment to submit record of progress on NATS portal for issuance of Certificate of Proficiency
- k. To organize concomitant activities as prescribed by BoAT (SR) Chennai, for effective implementation of NATS in Southern Region.

2) Terms and Conditions of empanelment as a TPA:-

- a. TPA should not approach/engage existing active industries registered with BoAT (SR), involvement in such practices, if found, will lead to de-empanelment of TPA.
- b. Your organization / Institution will be empanelled as TPA till 31st March, 2025 from the date of issuance of this letter, subject to monthly progress review by BoAT (SR), Chennai.

- e. BoAT (SR) Chennai, will have right to remove any organization / institution from the empanelled list at any time in cases where it is satisfied that the said organization / institution is not performing well as a TPA.
- f. BoAT (SR) Chennai, also reserves the right to modify the terms and conditions for empanelment of organization / institution from time to time and such modified terms shall be binding on the empanelled organization / institution.
- g. TPA shall not charge any fees from apprentices. However, it may consider processing fee from the establishment for services rendered such as mobilization of eligible candidates, and providing administrative support to the establishment to run its apprenticeship programme under NATS. BoAT (SR) is in no way concerned with this.
- h. The empanelled organization / institution is expected to maintain a high level of professional ethics and not act in any manner, which is detrimental to the interests of the BoAT (SR), NATS, Central Government/ State Governments(s) or allied departments/organizations MoE/DGET/ NSDC/SSDNS/MSDE of Government of India.
- i. The empanelled organization/institution shall report any legal action whatsoever initiated against it by any authority to BoAT (SR) Chennai immediately within a week of such an event, failing which empanelment of such organization/institution shall be removed with immediate effect.
