I have to inform you that u/s. 1(3) of the E.S.I. Act, 1948, the Central Govt. vide Notification No. S-38013/8/90 SSI dated 19/03/90 has made the pr ovisions of the Act applicable to all the factories coverable u/s. 2(12) of the Act, within the area specified in the notification w.e.f. 01/04/70

Under section 2-A of the Act, such factory to which the Act is applica ble is required to register itself under the Act and Chapter IV thereof casts a responsibility on the principal employer thereof to insure its employees and to pay contribution in respect of such employees covered under the Act.

On the basis of the particulars in respect of your factory submitted by you/the report of the inspection of your factory conducted by the Ins. Inspector on 26/03/08, your factory falls within the purview of sec. 2(12) of the E.S. Act. 1948, w.e.f. 01/01/08 (Prov.). In case, however, subsequent facts reveal that your factory was coverable from a date prior to the date mentioned above, you shall be liable to comply with the provisions of the Act from such earlier date.

You are requested to take immediate steps for :

- Registration of your employees (whose wages excluding remuneration for overtime are Rs.10000/- or below per month) under the Act by filling it and submitting Declaration Forms alongwith the photographs of employed es and their family members within 10 days of the receipt of this lef ter to Branch Office Ambad.
- 2. Payment of contribution and submission of Returns.
- 3. Maintenance of all the relevant records as per the provisions of the Act and the Regulations framed thereunder, from the date of coverage of your factory under the Act.

For the sake of convenience your factory has been allotted the Code No. 33-15822-67, which may be used in all communications sent to this office and all forms at the places indicated for the purpose.

You are requested to submit the said return in form 01-A every year so as to reach this office before 31st January of each year. A copy of form 01-A is enclosed. You are requested to submit the said return for the current year to this office immediately.

The Corporation officials would be pleased to render all necessary and possible assistance to you in discharging your duties and obligations under the E.S.I. Act 1948, and I am confident of prompt and timely compliance with the provisions of the Act and the Regulations on your part.
