**Sub: Implementation of the ESI Act, 1948-Registration of Factory Establishments under section 2(12) / 1(5) of the ESI Act, 1948.**

I have to inform that under section 1(3) of the ESI Act, 1948 the Central Government has vide notification No. S-38013/15/2003-SSI dated 02/04/2003 and the provisions of the Act applicable to all factories covered under the Act with the area.

2.a) I have further to inform you that the appropriate Government has extended the provisions of the Act to other establishments under section 1(5) of the ESI Act with effect from vide Notification No. dated .

b) I am also to inform you that extension of ESI Scheme under section 1(5) of the ESI Act, automatically made applicable w.e.f.16/05/1990 in terms of Ministry of Labour, Government of India Notification No.S-38012/6/89-SSI dated 16/05/1990.

3. Under section 2A of the Act, such a factory/establishment is required to register itself under the Act and Chapter IV thereof casts a responsibility on the principal employer thereof to insure its employees and to pay contributions in respect of such employees covered under the Act.

4. On the basis of the particulars in respect of your factory/establishment submitted by you on / the report of the Inspection conducted by the Inspector on 04/02/2009/Branch Manager on your factory establishment falls within the purview of Section 2(12) of the Act w.e.f. 02/01/2009 (Provisionally). In case, however, subsequent facts reveal that your factory/establishment was coverable from a date prior to the date mentioned above, you shall make yourself liable to comply with the provisions of the Act from such an earlier date.

You are requested to take immediate steps for registration of your employees by filling in Declaration forms, payment of contributions and maintenance of records etc., from the date of coverage of your factory/establishment under the Act.



For the sake of convenience your factory/establishment has been allotted Code No. **51-89697-67** which may kindly be used in all communications sent to this office and in all forms at the places indicated for the purpose. You are advised to contact **The Branch Manager, Branch Office(Pallavaram), ESI Corporation, ESI Dispensary (1st Floor), III, G.S.T. Road, Chennai-600 044. (PH: 22383664).**

They have been instructed to render necessary assistance to you in connection with registration of your employees. In case you find any difficulty or for any other purpose, which may be necessary in connection with the Scheme, you are requested to contact the Manager of the above Branch Office who will render necessary help in the matter.

It is requested that publicity be given to the list of Insurance Medical Practitioners/ State Insurance Dispensaries in your establishment to enable your employees to choose their State Insurance Dispensaries/ Insurance medical Practitioners. Required forms etc. may please be collected from the Branch Office mentioned above, to which all your employees will also be attached.

The Corporation officials would be pleased to render all necessary and possible assistance to you in discharging your duties and obligation under the ESI Act, 1948 and I am confident of prompt and timely compliance with the provisions of the ESI Act, 1948 & regulations on your part.
