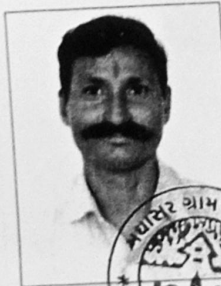

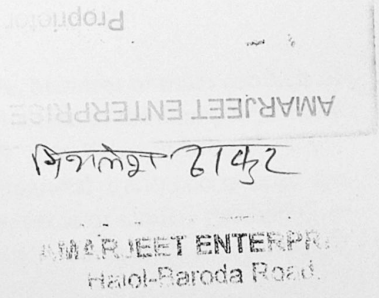

Intellectual Property or any tools, dies, mould(s), jigs and any other material provided by the Company. Vendor shall not be involved in and shall desist from any unfair or anti-competitive trade practices.

3. Protection of Confidential Information and Intellectual Property
