

## Memorandum of Understanding

Now, it is hereby agreed between both the parties as follows: -

- 1. The Company generates the hazardous waste at it manufacturing plant situated in Maharashtra region.
- 2. On 16th August, 2022, the Company and the Service Provider entered into a Service Agreement ("Service Agreement") to engage a the Service Provider for availing service related to collection and transportation of hazardous waste generated at various plants of the Company situated in Maharashtra to common disposal facility set up by Maharashtra Enviro Power Limited (MEPL) ("Services") to treat, store and dispose of the hazardous waste, as per the provisions of the Environment (Protection) Act, 1986 and the Hazardous and Other Wastes (Management and Transboundary Movement) Rules. 2016, as amended from time to time.
- 3. - 8. No amendments or modifications to this MOU shall be effective unless in writing and signed by the authorised signatories of the Parties.
