In this regards, we NSPL would like to submit our say as under :

01)As per present PF Rules, the PF is not mandatory to professional service
providers like Doctors, Consulting Engineers, Advocates, Consulting
Engineers (Competent Persons) etc.

02)NSPL is carrying out periodic Inspection Testing / Certification of various
Lifting Machines / Pressure Vessels / LPG Bullets / SRV etc as Govt.
Authorized Declared Competent Person once in six month (May 2 / 3 days)
and our total working days / year in any ETL organization is not more then 5

to 6 days in a year. Hence the rules / regulations of contractors shall not be made applicable to NSPL team members, since it is recognized as Professional Safety organization.

03) I the undersigned Milind Sangwkar is working as MD of NSPL and also practicing as Chartered Engineer / Govt. Registered Valuer / Class A Insurance Surveyor / DISH Approved Safety Auditor / Declared Competent Authority under the various Industrial Acts etc. We are working as Business Partner / Associate with ETL organization since from its establishment till date without any hassles and assisted ETL organization from time to time in many ways (i.e. As Auditor, As Valuer, As Service Provider for SEBI activities, As Surveyor and As Competent Person etc).

04) NSPL is a reputed professional safety organization and working / practicing with ETL for past 25 years as Govt.
