SAFETY AND HEALTH TRAINING

Training is one the most important components within our company's safety management systems. It gives employees an opportunity to learn their jobs properly, bring new ideas into the workplace, reinforce existing ideas and practices, and it helps to put our safety and health program into action.

MANAGEMENT COMMITMENT :

We will provide the necessary funds and scheduling time to ensure effective safety and health training is provided. This commitment will include paid work time for training in the language that the worker understands. Both management and employees will be involved in developing the program.

To most effectively carry out their safety responsibilities, all employees must understand (1) their role in the program, (2) the hazards and potential hazards that need to be prevented or controlled, and (3) the ways to protect themselves and others. We will achieve these goals by :

- Educating everyone on the natural and system consequences of their actions.
- Educating all managers, supervisors and employees on their safety management systems responsibilities.
- Educating all employees about the specific hazards and control measure in their workplace.
- Training all employees on hazard identification, analysis reporting and control procedures and
- Training all employees on safe work procedures and practice.

Our training will focus on healthy and safety concerns that determine the best way to deal with a particular hazard. When a hazard is identified, we will first try to remove it entirely.

TYPES OF TRAINING :

- General Safety Education: General safety information is communicated to employees on measurement of knowledge, skills and abilities.
- Specific Safety Training: Specific safety information and instruction on performing safe procedures and practices.

NEW EMPLOYEE ORIENTATION :

The format and extent of orientation training will depend on the complexity of hazard and the work practices needed to control them, orientation will include a combination of initial classroom and follow-up on the job training (OJT)

ON THE JOB TRAINING (OJT) :

OJT relates principal and theories to work skills that are then taught and applied in the work environment. OJT is designed to reinforce formal classroom training. All new hire employees require training to perform their jobs effectively.

All works will receive refresher training as necessary to keep them prepared for emergencies and alert them to ongoing housekeeping problems.
