- (2) The number of workmen employed as Contract Labour in the establishment SATYAM AUTO COMPONENTS PRIVATE LIMITED LTD, 103/3 Halol-2, Halol-Maswad Industrial Estate , Halol -Panchmahal-Gujarat, establishment shall not, on any day, exceed **150**.
- (3) Except as provided in the rules the fees paid for the grant, or as the case may be, for renewal of the license shall be nonrefundable.
- (4) The rates of wages payable to the workmen by the contractor shall not be less prescribed than the rates for the scheduled of employment under the Minimum 1948, where applicable , and the rates been fixed by agreement, settlement or award, not less than the rates so Fixed.
- (5) In cases where the workmen employed by the contractor perform the same or similar kind of work as the workmen directly employed by the principal employer of the establishment, the wage rates, holidays, hours of work and other conditions service the contractor shall of the workmen of be the same as applicable the workmen directly employed by the principal employer of the establishment on the same or similar kind provided of work; that in the case of any disagreement with regard to the type of work the same shall be decided by the Labour Commissioner, whose decision shall be final.
