Subject: Implementation of the ESI Act, 1948, (as amended) - Registration of establishments coverable under the Act.

Sir,

1. I have to inform you that U/s 1 (3) of the ESI Act the Central Govt. vide Notification No. 13 (8)/69/HI dated 28.03.69 has made the provisions of the Act applicable to all the factories coverable U/s 2(12) of the Act, within the area specified in the Notification w.e.f. 30.03.69
2. I have further to inform you that the appropriate Govt. has extended the provisions of the Act to other establishments w/s 1 (5) of the Act w.e.f. 1.1.90 vide Notification No. ESI-2787/1905/CR-295/87/MED-13, Dated 1.12.89

Under Section 2-A of the Act such Factory or Establishment to which the Act is applicable is required to register itself under the Act, and Chapter IV thereof casts a responsibility on the principal employer thereof to insure its employees and to pay contribution in respect of all employees covered under the Act.

4. On the basis of:-

- a. the particulars in respect of your Establishment submitted by you in Form 0-1 dated 8.3.06
- b. the report of inspection of your - conducted by the Ins. Inspector on -

your establishment falls within the purview of Sec. 1 (5) of the ESI Act, 1948 w.e.f. 1.10.04 (Prov.)

In case, however, subsequent facts reveal that your establishment was coverable from date prior to the date mentioned above, you shall be liable to comply with the provisions of the Act from such earlier date.

5. You are requested to take immediate steps for:-

- i. Registration of your employees (whose wages excluding remuneration for overtime are Rs.7,500/-) or below per month) under the Act by filling in and submitting Declaration Forms alongwith the photographs of employees and their family members within 10 days of the receipt of this letter to Branch Office 2 Aurangabad
- ii. Payment of contribution and submission of Returns.
- iii. Maintenance of all the relevant records as per the provisions of the Act and the Regulations framed thereunder, from the date of coverage of your establishment under the Act.

6. For the sake of convenience, your establishment has been allotted the Code No. 25-1876-101 which may be used in all communications sent to this office and all those of the place indicated for the purpose.
