Dear Sir,

We are pleased to offer you transport contract for transportation as per terms and conditions mentioned below.

A. General terms & Conditions

- **Vehicle Condition:** - Vehicle should be in good conditions in all season with safety.
- **Vehicle :-** The Service Provider shall make available the Vehicle for transportation of Equipment as and when demanded by Dhananjay Group.
- **Vehicle Loading & Unloading :-** The Service Provider shall ensure that while loading, during transportation and while unloading the Materials, no damage is caused to the Materials.

- **Delivery :-** The Service Provider shall transport the Materials as per Dhananjay Group instructions after Dhananjay Group entrusts the Materials to the Service Provider.

- **Behavior of Driver:** - Driver should not take smoking in on duty. He should wear safety shoes & proper dress code and he should talk to all in politely and soft language, also daily he should be present in company on time as informed by store team. At that time of loading of vehicle driver should be present at their place.

- **Insurance & Documents:** - M/s Shital Roadlines will ensure that the trucks are fully insured to the value of the vehicle with materials, transporter will ensure that the driver on the trucks also be insured.

- **Process of LR :-** At that time of loading the vehicle M/s Shital Roadlines should be prepare LR with mentioned invoice no details on the LR copy, no of packages (Box / Bins etc). And issue to Store team. And this is proof of handover materials to the M/s Shital Roadlines from the Dhananjay Group. And M/s Shital Roadlines is whole responsible for delivered the material to the customer end on time.

- **Receipt of Acknowledgement:** - After delivered material to the customer then submit the acknowledgement copy to the Store dept. with customer signature & stamp. And make store person signature on second copy of LR, and this is valid proof for billing.

- **Delay in the Delivery:** - Shital Roadlines will be granted to PN delivery materials will be delivered within 08 days to for the **PN location** customer. And for **Pritampur location** delivery will be delivered in next day of handover the materials by Dhananjay Groups. If the M/s Shital Roadlines is unable to delivered materials as per above lead time and in that case customer line will be suffer then M/s Shital Roadlines will be

whole responsible for it. And Dhananjay group will reserve the right to charge the M/s Shital Roadlines for the Dhananjay Group of 15% value of the invoice. If trucks are breakdown then M/s Shital Roadlines will arrange another vehicle & delivered material to the customer within time.

- **Missing Materials :-** If any materials is missing during the transport in that case invoice value will be debit to M/s Shital Roadlines.
- **Short Qty Delivered :-** If any Bins / Boxes short delivered to the customer by M/s Shital Roadlines then short Qty materials value should be debit to M/s Shital Roadlines.
- **Materials Damaged :-** If any materials damaged while transportation then M/s Shital Roadlines will whole responsible for this and whatever materials damages which is recover value from the transporter. And if need to be segregate the damaged materials for run the customer line then segregate manpower charges & rejected material charges will be bear by M/s Shital Roadlines.
- **Vehicle Breakdown :-** In case of breakdown of the vehicle on the way, Service Provider shall ensure availability of alternate vehicle within ~~one hour~~ ^{one 2 days} (OR reasonable agreed time) of break down and complete the trip at your own cost.

B. General Provision

➤ **Termination of Agreement :-** This is agreement is made only for mutual understanding of both party's & termination if this agreement fully authorized by Dhananjay Group.

➤ **Transportation Charges :-** Price revision is subjected to approval from our customer that is Bajaj Auto Ltd. In case price revision need to be take approval from BAL then only it can be passed on to M/s Shital Raodlines.

This is agreement is between the transporter and Dhananjay Group management people. Dhananjay Group having fully authorized to cancel the agreement without Prior conditions.
